Returns:	 a) Upon receipt of shipment and before cutting, inspect carefully for correct colour, design, quality, and quantity. Regardless of fault, all returns must be made within 30 days of receipt of shipment, and must be authorized by management. b) No merchandise will be accepted without a return authorization number. c) Merchandise will not be accepted for credit once it has been cut or applied. d) Claims for labor charges will not be allowed under any circumstances. e) Merchandise will not be accepted for credit after 30 days. f) For those orders that are approved for return by management, there is a 25% restocking charge. g) Trimming of less than ten meters is not returnable. h) Special orders and non-stock product orders are not returnable. i) Merchandise will not be accepted for credit once it has undergone an outside process, such as flame proofing, water repelling, stain resistance, piece dyeing, etc. j) Authorized returns should be returned to Samuel & Sons. 3.13 Chelsea Design Centre, Chelsea Harbour, London SW10 OXE k) Piece merchandise, such as tassels and rosettes, may be returned within two weeks for full refund. No refunds will be permitted after two weeks from time of purchase.
